Fire Code Edit Sub-Committee Proposals (For Reference)

- •This document is a portion of the Statewide Fire Prevention Code proposal from the Fire Code Edit Sub-Committee that was submitted during the Proposed Phase. Tab 1 only includes the portion of the Fire Code Edit Sub-Committee proposal (Chapter 1 through Chapter 10, section 1003.7) that was reviewed by the Fire Code Edit Workgroup.
- Fire Code Edit Sub-Committee: BHCD sub-committee formed to review the Statewide Fire Prevention Code (SFPC) and develop a proposal that would remove the unenforceable provisions from the SFPC.
