CSV Technical Guidelines

& examples for BEAD Negotiation Portal (v.2025.07)

To submit multiple addresses in one submission, ensure your CSV (comma-separated values) file adheres to the format outlined below. Proper formatting is crucial; deviations will lead to a 'Rejected Address' status. For detailed guidance, see the information provided below.

CSV Standards

When viewed in Notepad or similar text editors, your CSV file should resemble the examples given below. The required headers/fields are: location_id, classification, prop_deobligation, req_funds, match_25, techcode, download_speed, upload_speed, low_latency, deployment_time, and cluster.

If **prop_deobligation** is 1 (true), applicants should submit the required information to broadband@dhcd.virginia.gov after submitting their CSV. Locations proposed for de-obligation should have zeroes for the other fields.
