HOPE is seeking a renewal of the HUD RRH project that was awarded in the past year, and which came under contract with an effective date of 7-1-15. Prior to this award, we had experienced a voluntary reallocation of some of our PSH funding. HOPE had participated in the NAEH Learning Collaborative, 100 Day Challenge, and other technical assistance initiatives offered over the past couple of years, to build our capacity in rapid rehousing.

HOPE has received Va DHCD Homeless Solutions Grant (VHSP) support consistently over the years, for prevention, shelter and rapid rehousing, including state rapid rehousing funding this fiscal year for veterans's initiatives. The HUD RRH has been tailored to serve homeless families with children.

All clients seeking shelter are required to go through the Coordinated Community Response to Homelessness Housing Solutions Coordinator, working out of our main office at the HOPE Ministry Center, in downtown Wytheville. This full time position, funded by Va. DHCD, serves as the primary point of contact for all persons seeking services who are homeless or at risk of becoming homeless. The Coordinator completes the intake and needs assessment with each client, entering that into our HMIS, and makes the appropriate referral to one of our three housing counselors to address the client's need. The coordinator and the client work together to determine what resources are available to allow the client to remain in their current housing through prevention or diversion services whenever possible. Clients who are eligible for prevention services will receive an immediate referral to the Prevention counselor, who will work with them to prevent homelessness through mediation, lease counseling and financial assistance as necessary and as available.

The RRH Case Manager will meet with the client to complete a housing barrier assessment and VISPDAT. The case manager will determine if the client should be placed in RRH or might be eligible for PSH. The client will be referred to the appropriate case manager to develop a housing stabilization plan with a primary focus on obtaining permanent housing, and a secondary focus on housing stability. RRH Case Managers will assist clients with identifying available housing units, completing rental applications, arranging for and viewing the units and with understanding leases. The Case Manager will work with landlords to address concerns about housing barriers and explain the services offered to the client, including connecting the client to all available main stream benefits.


