## 3B. Project Description

### 1. Provide a description that addresses the entire scope of the proposed project.

Human beings are not meant to live on the streets, in their cars, or in the woods. It is predominantly true in rural and transitional areas where homelessness is often less visible than in urban areas. Many rural homeless people live in places unseen by the public eye; they are often sleeping in the woods, campgrounds, cars, abandoned farm buildings, or other places not meant for human habitation. Ending homelessness requires financial assistance and counseling programs designed for individuals and families to help them secure self-sufficiency. Without supportive services, housing is often not enough to end homelessness. Annually, New River Community Action (NRCA) participates in a Point In Time Count (PITC). This national event is a counting of all identified persons who are homeless on a specific night of the year providing a snapshot of homelessness in the nation. The New River Valley region's PITC in January 2018 identified 75 homeless individuals (48 sheltered; and an alarming 27 unsheltered). This was a significant increase from the 2017 PITC homeless findings of 69 homeless individuals with only four of the 69 individuals unsheltered. NRCA worked with community partners to identify where homeless persons would likely be located on the night of the PITC. Rapid Rehousing is an effective intervention for various types of households experiencing homelessness, including those with no income, disabilities, and with poor rental or criminal history.
