The Flagler Housing Resource Center (HRC) is a program of St. Joseph's Villa's (SJV) Housing & Homeless Services, serving the Crater Area Coalition on Homelessness – Local Planning Group (CACH LPG), within the Balance of State Continuum of Care (CoC).

The goal of the RRH program at SJV is to combat homelessness by giving families and individuals the tools they need to regain long-term stability. RRH is time-limited, usually 90-120 days, and addresses the three core components of RRH; 1) housing identification; 2) financial assistance, and 3) case management. After households have identified and secured stable housing, SJV works diligently to address factors that led to homelessness/housing instability and empower households to develop and pursue goals using a strengths-based Housing Stabilization Plan. SJV connects households to resources including mainstream benefits (SSDI/SSI, SNAP, TANF, etc.), mental health skill-building, healthcare, and other services. SJV relies on strong relationships with community agencies to ensure households can successfully increase personal and financial stability.

In keeping with federal guidelines and best practices, SJV prioritizes housing interventions for chronically homeless participants and those with the highest barriers to housing, including youth, seniors, and those with chronic health concerns. Preliminary data collection has shown two populations to be especially in need of housing assistance and housing stabilizing in the Crater region: non-chronic singles and young parents. SJV is working to strengthen partnerships with affordable housing providers, public housing authorities, and faith-based communities- to continue serving individuals and families who require a wide spectrum of housing interventions.

With this HUD 2018 Renewal grant, combined with state and private funds SJV will provide RRH to 120 households including families, single adults, and youth experiencing homelessness, ages 18-24. SJV will continue to ensure that 85% of homeless households will exit into permanent housing of which 85% will remain housed 12 months after program discharge.
